Real-time transmission of streaming video, digital images, real time audio is the exclusive right of HUSET'S SPEEDWAY, FloRacing.com and Dirtvision.com is otherwise prohibited.

No logo, trademark, advertisement, or other graphic shall be superimposed, or incorporated in any highlights without prior written permission of HUSET'S SPEEDWAY, FloRacing.com and Dirtvision.com.

The Accredited Party and Pass Holder acknowledge that the nature of auto racing involves inherent risks and dangers to persons attending the events, acknowledge that they have been warned that by attending the Events there is the possibility of an accident causing, injury, death or property damage.

The Accredited Party and Pass Holder agree to waive any rights or claims they may have now or at any time in the future against, and releases from all liability, agrees not to sue and indemnifies FR2SD, LLC dba HUSET'S SPEEDWAY, any particular team or driver, landowners and lessees and other organizations connected to the events and their directors, members, officers, employees, agents and contractors for any personal injury, death, damage or loss of any kind that the pass holder may suffer or incur.
